10:15 am – 11:45 am: Seminar 2: Dosing Tools in School-based Practice | Sue Cecere, PT, MHS

What tools can assist you in determining appropriate dosing for school-based therapy services? In this course, Sue will lead you in an exploration of 3 different tools for deciding dosage (the CERT, the DRTT, APTA's dosing manual) using a case study. You will draw lessons regarding the strengths and limitations of each tool. Based on these lessons, Sue will discuss dosing decisions in relation to different service delivery models, including direct services, integrated services and services on behalf of the student.

1. Identify 3 concepts for making school-based dosing decisions
2. Determine 2 uses of a dosing tool to support decision-making on the amount of therapy support needed by a student to meaningfully participate in their education

12:15 pm – 1:45 pm: Seminar 3: Evidence-based Practices for Indirect and Direct Services | Peggy Morris, OTD, OTR/L, BCP

Whether you are providing services directly or indirectly, you can be an evidence-based practitioner! In this course, Peggy will utilize a case study to walk therapists through a clinical reasoning model to provide you with evidentiary support for your interventions. You will learn to plan a treatment sequence that closely adheres along the continuum of the least restrictive environment. Peggy will then tie all the concepts learned via a flexible service delivery grid to move your practice forward in promoting your client's participation and occupation. Finally, Peggy will share with you the 5 Steps to presenting to the family, teacher, and other IEP team members the clinical reasoning for your service recommendations in a way that can help promote understanding & buy-in.

2:00 pm – 3:30 pm: Navigating Discontinuation of School OT or PT Services | Carlo Vialu, PT, MBA

When is it time to discontinue services—and how can you gain support from parents and educators when making that recommendation? These conversations can be challenging, but the right knowledge and approach

make all the difference. Carlo begins by highlighting research on factors that influence parent satisfaction with the IEP process and teacher perspectives on collaboration with related service providers. From this foundation, he shares six essential best practices to support clear communication, establish your role, and build trust with families and educators. Carlo then addresses when discontinuation is appropriate, reviewing legal and professional guidance and focusing on three common scenarios: when goals have been met, when benefits have been maximized, and when a student chooses to conclude services. You'll learn practical strategies for presenting data, responding to common pushbacks, and reframing "discontinuation" as graduation to support a more positive, student-centered conversation. Leave this course with practical strategies to navigate these important discussions with clarity, confidence, and professionalism.
